Only team members entered are allowed to hunt.

No pooling of animals.

No hunting public roads, out of helicopters or planes, boats, snares, or traps.

Clock at registration is official clock.

All teams returning after 1pm on Sunday April 11th, 2010 will be disqualified. (No Exceptions)

All disputes must be made before 1pm on Sunday April 11th, 2010.

Judges decision is FINAL!!!!!!!

One team member must be present to enter the team.

All hunters are subject to a polygraph test.
